Subject: Provision of exchange to SBN - cash withdrawal from banks

Dear Sir / Madam,

Please refer to letter RBI circular DCM (Plg) No. 1226 / 10.27.00 / 2016-17 dated November 08, 2016 regarding withdrawal of legal tender character of SBN. In partial modification to the instructions conveyed therein, you are requested to take note of the following:

1. State Government makes pension disbursement to old age people through pension disbursing authorities in blocks and gram panchayats. Banks are advised to allow, if approached by the pension disbursing authorities, cash withdrawals, beyond the stipulated limit of Rs. 10,000/- per day, from the accounts maintained by the concerned government departments with them. This may be done on production of evidence justifying the cash requirements of the disbursing authorities.
2. Banks are also advised to allow cash withdrawal, beyond the stipulated limit of Rs. 10,000/- per day, to other banks and post offices maintaining current accounts with them.

**Likelihood of disruption in disbursement of pension due to
Demonetization to indigent pensioners in the State.**

2. In this connection, we advise that the banks in the State have been instructed to allow withdrawal of cash by the Pension Disbursement Authorities in Blocks and Gram Panchayats over and above the existing limit of R.20,000/- per week as a special case.
